## Membership Subscription Rates : 2024-25

At the 141<sup>st</sup> Annual General Meeting of the Association held on 8<sup>th</sup> November 2024, Association's Budget for the year 2024-25 was passed and new rates of membership were proposed and unanimously passed by members.

Accordingly, following Resolutions were proposed and unanimously passed at the 141<sup>st</sup> AGM :

a) Proposed by Mr Suneel Singh Sikand, Vice-Chairman and seconded by Mr Raghav Poddar, the following Resolution was unanimously adopted and passed :

(i) *"Resolved that the meeting hereby approves the Budget for 2024-25 involving total expenses of Rs. 1467.12.lakhs"*

b) Proposed by Mr Suneel Singh Sikand, Vice-Chairman and seconded by Mr Mayank Beriwala the following Resolutions were unanimously adopted and passed :

(i) *"Resolved that the rates of Membership Subscription in respect of Ordinary Members of the Association for the financial year 2024-25 in Assam Valley, Cachar Valley, Dooars, Terai and Darjeeling regions be fixed at the following rates on the highest crop of made tea produced from own leaf in the block of Calendar years 2020, 2021 & 2022".*

Region	Rs per Quintal
Assam Valley	40.85
Cachar	35.73
Dooars	37.01
Terai	31.90
Darjeeling	81.68

(ii) *"Resolved that the rate of Membership Subscription in respect of Ordinary Members of the Association for the Financial Year 2024-25 on the crop of made tea produced from Bought Leaf in the Calendar year 2023 be retained at the existing rate of Rs. 4/- per quintal per annum"*

- (iii) "Resolved further that the Associate Membership Subscription rate for the Financial Year 2024-25 for Small Growers for who have tea estates below 50 hectares be fixed at pre-existing rate of Rs. 15,000/- per annum".
- (iv) "Resolved further that the Associate Membership Subscription rate for the Financial year 2024-25 in respect of Small Growers for Bought Leaf Factories (BLF) be fixed per annum at the pre-existing rates as follows:

Production	Rate (Rs)
Upto 5 lakhs kg	15,000.00
Over 5 lakhs and upto 10 lakhs kg	25,000.00
Over 10 lakhs and upto 20 lakhs kg	35,000.00
Over 20 lakhs kg	50,000.00

Arrear Membership Subscriptions for the 1<sup>st</sup> 2<sup>nd</sup> and 3<sup>rd</sup> quarters of 2024-25 following above enhancement would be sent along with Membership Subscription intimation letter for the 4<sup>th</sup> quarter ending 31<sup>st</sup> March 2025.
