## Indian Tea Festival in Turkmenistan

Members are informed that the Embassy of India, Ashgabat, Turkmenistan proposes to organize an Indian Tea Festival during last week of May, 2025 to highlight 200 years of Assam Tea.


The Embassy has requested the Secretary, Dept. of Commerce, Ministry of Commerce & Industry, Govt. of India –

- to mount a business delegation of Indian Tea exporters during the Indian Tea Festival to facilitate B2B meetings, fostering meaningful trade discussions.
- to supply different varieties of Indian tea for the festival.

In this connection, the Tea Board has sought the Association's urgent views on the feasibility of mounting a trade delegation to Turkmenistan and also requested Indian exporters to send fresh season teas for supplying to the Embassy of India, Ashgabat, Turkmenistan.

In this connection, an email received from Mr. Joydip Biswas, Dy. Director, Tea Board India forwarding a DO letter received from the AOI, Turkmenistan and a note prepared by Tea Board on Turkmenistan market are enclosed for members' kind reference.

The attached DO letter from the AOI, Turkmenistan addressed to the Secretary, Department of Commerce may kindly be perused.

The said letter proposes to organise an "India Tea Festival" in Ashgabat during the last week of May '25. As per the letter, the event is envisaged to showcase various operators from the local tea trade (retailers, wholesalers, supermarket owners etc) as well as the government officials for substantive promotion of diversified bouquet of "India Tea" including holding testament to the glorious journey of "200 years of Assam Tea" at the show.

Although the letter has mentioned a very high level of tea consumption in Turkmenistan - green tea being sourced from China, whereas black tea from UAE, the following Turkmenistan tea market characteristics culled out from my old note are produced for reference and suitable amendment at your end. At the same time, an earlier small market note received from the EOI, Ashgabat is also attached for your reference.

### Tea Market characteristics in Turkmenistan

- ⦿ Tea is very popular drink being consumed heavily on every cultural occasion
- ⦿ Total market size is estimated to be 15 million kg per annum
- ⦿ Per capita consumption is around 1.5 kg per annum
- ⦿ Green tea is the most preferred choice (70% of total consumption), followed by Black tea (30%)
- ⦿ Of late, demand for packed tea and tea bags has increased considerably
- ⦿ Sri Lanka has the overwhelming share in the import market. Additionally, teas are sourced from Georgia, China, UK and India (nominal quantity)
- ⦿ The leading umbrella brands operating in the market are "Beta Champion" and "Pasha Tea" having a number of line extensions
- ⦿ Cheaper Chinese tea and Quality Sri Lankan tea are the major competitors to Indian tea in the loose and packed segments respectively
- ⦿ The largest tea-packing plants and the largest tea suppliers in Turkmenistan are located in Ashgabat
- ⦿ The market is overwhelmingly dominated by two Turkish Companies viz. Teksun and Beta. They have been in operations since 1996
- ⦿ Traditional channels of sale of tea & tea products are common grocery stores
- ⦿ Tea is mainly channelised through Bandar Abbas port of Iran

P The main tea-growing region is located mid-way on the North-South Transport Corridor.

The AOI's letter has also indicated that there is also a proposal of establishing a tie-in with the Government of Turkmenistan, who is also a big tea buyer. Further, Turkmenistan Airlines is also another significant tea purchaser and it has expressed keenness in introducing "India Tea" on its international and domestic flights.

In the above backdrop, your valued opinion/interest is solicited at the earliest regarding the feasibility of mounting a trade delegation to this new market. Accordingly, the Ministry and the Embassy will be intimated.

Moreover, fresh season teas may kindly be arranged to be supplied for the Festival as has been requested by the AOI, Turkmenistan. We're supplying a number of single-origin tea caddies for the same.

Greetings from Ashgabat, Turkmenistan!

The Embassy of India, Ashgabat, Turkmenistan proposes to organize an **Indian Tea Festival**, during last week of May 2025. The event is envisaged to bring together government officials, supermarket chains as well as private importers in Turkmenistan, providing them with an opportunity to explore and experience the rich variety of Indian teas. The event proposes to highlight 200 years of Assam Tea.


Turkmenistan has a high level of tea consumption, especially black and green tea, primarily imported from China and UAE. The Government of Turkmenistan is also a large purchaser. Given the quality and variety of tea that India produces, there exists immense potential for export of tea in this market. Turkmen airlines (a significant buyer) is operating regular flights (twice in a week) on the Delhi-Ashgabat route and has also expressed interest in introducing Indian tea on its international and domestic flight routes. This festival is aimed at providing a valuable platform to bring together relevant stakeholders from India and Turkmenistan and give impetus to capitalize on this market.

I would greatly appreciate if the Department of Commerce could support in procurement and supply of different varieties of Indian Tea for organizing the proposed event. It is also proposed to consider mounting a business delegation of Indian tea exporters during the festival to facilitate B2B meetings, fostering meaningful trade discussions. It would be deeply appreciated that consignments of tea could be sent along with promotional materials to showcase India's tea heritage.

### **Tea in Turkmenistan**

Tea (Chai in Turkmen language) is very popular and part of culture in Turkmenistan. People take tea with anything they eat. Some people take tea in huge quantity as substitute of water. During the Soviet time Indian **black** tea was very popular, alongside Georgian **green** tea. Georgian green tea being the cheapest even though inferior in quality has remained the first choice of poor people.

A sizable portion of the population (app 35-40 %) mostly in Lebap and Ahal province are fond of black tea, which is mostly imported from Sri Lanka. Green tea is imported from Georgia and China.

### **Quantity of tea Consumption-**

In 1 year 1.5 kg/per person =  $1.5 \times 5,000,000$  people = 7,500,000 kg or 7500 tons (in India little less than 1 kg per person consumption)

### **Quality**

Mainly low-medium quality tea. However the taste and demand for high quality tea is growing at a fast pace in last few years.

### **Countries**

Tea is imported mainly from Georgia, China, Sri Lanka, India and UK

### **Price**

Different prices for different quality. Lowest quality tea is being sold at 10000-15000 manat /kg(Rs. 20-30).Mainly Georgian and Chinese. Poor people mostly buy it.

**Impra ,Ahmad, Lipton sell both leaf/dust tea and tea bags.**

In shopping malls and at few public places one comes across advertisements of Impra tea (Sri Lanka) and Lipton. Assam tea, Darjeeling tea, Neelgiri etc are being sold by Lipton UK.

**Government Purchase of tea-:**

- Government is a big buyer in Turkmenistan. It has retail stores in almost all towns/villages.
- In 2006, State Wholesale-Retail Trade Firm "Turkmen grocer's shop" of Ministry of Trade purchased 217 tons of tea from China, Georgia and Sri Lanka.
